Information on candidate's personal data processing

Dear candidate,

with reference to our recruitment activity to which you are participating, we inform you that we need to process your personal data for the purposes and according to the conditions mentioned here below.

1. Controller

The Controller who determines the means and purposes of personal data processing is SMI SPA, with head office in Via C.Ceresa 10 in San Giovanni Bianco.

2. Purposes of data processing, processing modes, lawfulness

The personal data collected during the pre-selection interview will be processed for the following purposes and legal basis:

3. Recipients - categories of recipients

Personal data shall be disclosed to comply with the regulations and shall be exclusively processed by authorized personnel :

4. Data transfer abroad

Your personal data shall not be transferred abroad.

5. Data storage period and criteria used to determine that period

Personal data shall be collected and stored for the purposes mentioned here below.

6. Rights of the data subject

You are entitled to exercise your rights under this Regulation in respect of and against the Controller.

- <u>Right of access</u>: according to art.15 of EU Regulation you have the right to obtain from the controller confirmation as to whether or not your personal data are being processed, and, where that is the case, access to your data.
- <u>Right to rectification</u>: according to art. 16 of EU Regulation you have the right to obtain from the controller without undue delay the rectification of inaccurate personal data. Taking into account the purposes of the processing, the data subject shall have the right to have incomplete personal data completed, also by providing a supplementary statement.
- <u>Right to erasure</u>: according to art. 17 of EU Regulation you have the right to obtain from the controller the erasure of your personal data without undue delay where one of the provisions of the regulation applies.
- <u>Right to restriction of processing</u>: according to art. 18 of EU Regulation, you have the right to obtain from the controller restriction of processing where one of the provisions of the Regulation applies.
- <u>Right to object</u>: according to art. 21 of EU Regulation, you have the right to object to processing of your personal data at any time on grounds relating to your particular situation, based on art. 6 (1) point (e) or (f), including profiling based on those provisions.
- <u>Right to data portability</u>: according to art. 20 of EU Regulation, you have the right to receive your personal data, which you provided to a controller, in a structured, commonly used and machine-readable format and have the right to transmit those data to another controller without hindrance from the controller to which the personal data have been provided.
- <u>Right to withdraw your consent</u>: according to art. 7 of EU Regulation, you have the right to withdraw your consent at any time. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal.
- <u>Right to lodge a complaint</u>: according to art. 77 of EU Regulation, you have the right to lodge a complaint with a supervisory authority, in particular in the Member State of your habitual residence, place of work or place of the alleged infringement, if you consider that the processing of your personal data infringes this Regulation.
